STANDARDISED PRICE LIST

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL (Funeral Director's charges only) - £1150

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial:

- Taking care of all necessary legal and administrative arrangements (£150)
- Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into our care **(£200)**
- Care of the deceased before the funeral in our facilities. The use of the Washing facility and Storage facility (Mortuary) **(£300)**
- Providing a Coffin (this will be a Oak Veneer Coffin) (£300)
- Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer) (**No Charge** for this but all viewings must be by appointment)
- At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery (normally within 15 miles of the funeral director's premises) in a hearse or other appropriate vehicle **(£200)**

UNATTENDED FUNERAL - £1150

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial itself.

• These are the funeral director's charges only - (£1150)



FEES YOU MUST PAY

For an Attended or Unattended funeral, the burial and Interment fee must be paid by the family or friends.

In this local area of Birmingham City Council, the typical cost of a new grave for burial including Interment fee for local residents is:

£4070 for Earth Grave (75 years lease) / £4950 for Earth Grave (75 years lease) £5571.50 for Concrete Liner (75 years lease) / £6451.50 for Concrete Liner (75 years lease)

For a new grave, you need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

Please discuss any specific religious, belief-based and/or cultural requirements that you have with the funeral director.

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

- Additional mileage (i.e. if collection is from outside 15 miles away from CSMA premises up to 30 miles away) (£100)
- Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer) (£100)
- Ghusl Packs (includes kit for ghusl) (£50)
- Embalming Certificate (£195 £210)
- Funeral Imam to attend burial (Please contact the Masjid for information)
- Services supplied outside of normal office hours (Prices on request)

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

REPATRIATIONS ABROAD

£1450 plus Disbursement costs (i.e Freight charges) which will vary depending on the airline carrier, weight & dimensions of the casket being transported. Please note that the above costs are for transport to Birmingham airport, additional costs apply should transport be needed to any other airport. Additional £100 charges apply to Manchester, Heathrow & Gatwick Airport repatriations.
